# MINUTES OF THE ADJOURNED MEETING OF THE BOARD OF DIRECTORS OF THE VISTA IRRIGATION DISTRICT

#### February 18, 2015

An Adjourned Meeting of the Board of Directors of Vista Irrigation District was held on Wednesday, February 18, 2015, at the offices of the District, 1391 Engineer Street, Vista, California.

#### 1. CALL TO ORDER

President MacKenzie called the meeting to order at 8:30 a.m.

#### 2. ROLL CALL

Directors present: Miller, Vásquez, Dorey, Reznicek, and MacKenzie.

Directors absent: None.

Staff present: Roy Coox, General Manager; Lisa Soto, Secretary of the Board; Don Smith, Director of Water Resources; Brian Smith, Director of Engineering; Brett Hodgkiss, Administrative Services Manager; Frank Wolinski, Operations and Field Services Manager; and Marian Schmidt, Administrative Assistant. General Counsel Joel Kuperberg was also present.

#### 3. PLEDGE OF ALLEGIANCE

Director Reznicek led the pledge of allegiance.

#### 4. APPROVAL OF AGENDA

#### 6. CONSENT CALENDAR

Upon motion by Director Vásquez, seconded by Director Reznicek and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Reznicek, and MacKenzie), the Board of Directors approved the Consent Calendar, including Resolution No. 15-06 approving disbursements.

## 8. 2015 ACWA/JOINT POWERS INSURANCE AUTHORITY EXECUTIVE COMMITTEE ELECTION

General Manager Roy Coox stated that an additional request for concurrence was received the previous day via email from Rancho California Water District (attached hereto as Exhibit A). The request was to concur in the nomination of John E. Hoagland to the ACWA/JPIA Executive Committee. Mr. Coox said that the title for this agenda item does allow for this additional request to be considered by the Board at this time. The Board discussed both requests, noting that it would be allowable to the Board to provide concurrence in the nominations of multiple candidates if it so desires. Director Dorey stated that as a candidate in the election, he was willing to concur in the nominations of other candidates as well.

Upon motion by Director Dorey, seconded by Director Reznicek, the Board of Directors adopted Resolutions 15-07 and 15-08 concurring in the nominations of W.D. "Bill" Knutson of Yuima Municipal Water District and John E. Hoagland of Rancho California Water District respectively, for the ACWA Joint Powers Insurance Authority Executive Committee, by the following roll call vote:

## 9. MATTERS PERTAINING TO THE ACTIVITIES OF THE SAN DIEGO COUNTY WATER AUTHORITY

Director Miller reported that he attended a special meeting of the Engineering and Operations (E&O) Committee to review the Pumped Storage Project at the San Vicente dam. Director Miller said that in the following week, the E&O Committee would be presenting its recommendation to continue to budget for this project to the Water Authority Board. Director Miller said that the next step will be to complete the FERC licensing permit application for the Pumped Storage project. Director Miller said that it is anticipated that in March the Water Authority Board will finally discuss the proposed new water rate structures.

# 10. REPORTS ON MEETINGS AND EVENTS ATTENDED BY DIRECTORS, AND AUTHORIZATION FOR DIRECTOR ATTENDANCE AT UPCOMING MEETINGS AND EVENTS

Director Vásquez reported on his attendance at a Region 10 Board meeting the previous week. He also reported on his attendance at a meeting of the ACWA Water Quality Committee. He noted that there was an interesting presentation on the Central Valley Salinity Alternatives for Long-term Sustainability (CV SALTS) Project concerning the impacts of the salinity and nitrates on agriculture and drinking water supplies in the Central Valley. Also at the ACWA Water Quality Committee meeting, Cindy Forbes, the Deputy Director of the State Water Resource Control Board's (State Water Board) Division of Drinking Water, provided an update regarding the current activities of the State Water Board.

Director Dorey reported on his attendance at a meeting of the Upper San Luis Rey Watershed Authority (USLRWA) where Lin Burzell, General Manager of Yuima Municipal Water District and President of the USLRWA, announced that he is planning to retire in about two years. Consequently, there was a discussion about succession planning for the USLRWA Board. Director Dorey also reported on his attendance at the Council of Water Utilities meeting the previous morning where U.S. Navy Captain Darius Banaji gave a presentation on Navy Conservation Initiatives.

President MacKenzie reported on her attendance at the ACWA Region 10 meeting where she made a presentation regarding the activities of the ACWA Local Government Committee. President MacKenzie reported on what it means to be an ACWA Outreach Ambassador. She said that ACWA Outreach Ambassadors are the individual members who actively participate in the ACWA Outreach Program. They are on ACWA Committees and on the ACWA Regional Boards and they make up the network of individuals that ACWA calls to action when grassroots support is needed on a legislative, regulatory, or policy issue. Outreach Ambassadors are recognized at ACWA Conferences by an orange ribbon on their name tag.

#### 11. ITEMS FOR FUTURE AGENDAS AND/OR PRESS RELEASES

#### 12. COMMENTS BY DIRECTORS

Director Reznicek encouraged his fellow Board members to check out a new website called Maven's Notebook, a website dedicated to California Water Issues. The website is created and published by Chris Austin, creator and former publisher of Aquafornia. Director Reznicek said that he likes this website because it appears to present all sides of California's complex water issues without a particular agenda. He especially recommended the photo blog which contains a lot of great historic photos of water in California.

#### 13. COMMENTS BY GENERAL COUNSEL

General Counsel Joel Kuperberg reminded the Board that the Form 700 Annual Conflict of Interest Statements are due by April 1, 2015. Mr. Kuperberg updated the Board about the issue of serial meetings by email. He reminded the Board that when one director sends an email to the rest of the Board on an issue related to District business, this creates the potential for a serial meeting, particularly if someone replies, or even worse replies to all. He explained that this practice moves the group towards collective concurrence on an issue, which is defined as a meeting under the Brown Act. Mr. Kuperberg said that this is just a reminder, and he has no reason to believe that this is an issue for the VID Board.

#### 14. COMMENTS BY GENERAL MANAGER

Mr. Coox informed the Board that the water level at Lake Henshaw was currently at 4,600 acre feet. Mr. Coox said that as part of the District's ongoing Love Tap! campaign to encourage drinking tap water, staff will be making presentations at Breeze Hill Elementary School to all grade levels on February 26. Later in the week Mr. Coox said that he would be meeting with City Manager Patrick Johnson to discuss installing hydration stations at two City of Vista facilities.

#### 15. CLOSED SESSION FOR CONFERENCE WITH LEGAL COUNSEL

President MacKenzie adjourned the meeting to closed session at 9:01 a.m. for a conference with legal counsel per Paragraph (1) of subdivision (d) of Government Code section 54956.9 to discuss the following pending litigation:

- A. San Luis Rey Indian Water Rights Litigation (Settlement)
- B. Quantification Settlement Agreement (QSA)

The meeting reconvened in open session at 9:33 a.m. President MacKenzie declared that no reportable action had been taken. At this time President MacKenzie directed that Item 12 of the agenda be revisited to finalize any comments that were inadvertently skipped earlier in the meeting.

#### 12. COMMENTS BY DIRECTORS

Director of Water Resources Don Smith updated the Board on a construction project the District is working on near Director Miller's residence. On a different matter, Director Miller requested clarification on an inquiry he received regarding what appears to be a Temporary Service Agreement (TSA) issue on the northeast side of Highway 78. Mr. Coox responded that the District is scheduled to perform a mainline replacement in the area described by Director Miller. Mr. Coox said that one of the TSA property owners has a very large frontage, and his share of the cost is going to be much higher than the other affected property owners with smaller frontages. Mr. Coox said that all of the property owners were aware of this future obligation (TSA) when they purchased their respective properties and unfortunately, each owner is now obligated to share in the cost of extending the system to their properties.

#### 16. ADJOURNMENT

There being no further business to come before the Board, at 9:37 a.m. President MacKenzie adjourned the meeting.



<u>SUMMARY</u>: The water system is ready for acceptance by the Board which will allow the Notice of Acceptance to be filed with the County Recorder.

<u>DETAILED REPORT</u>: All the work required by the construction contract (WOI-3059) has been completed. Under District inspection, the developer's contractor installed approximately 529 feet of 8" PVC pipe, 17 - 1" service laterals with 16 - 1" domestic meters and one 1" irrigation meter, and two 6" standard fire hydrants.

By representing you and the other JPIA members on the Executive Committee, I can help continue the thoughtful policy guidance of the Authority to meet the changing landscape of risks that our agencies face every day.
