MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE VISTA IRRIGATION DISTRICT

November 4, 2015

A Regular Meeting of the Board of Directors of Vista Irrigation District was held on Wednesday, November 4, 2015, at the offices of the District, 1391 Engineer Street, Vista, California.

1. CALL TO ORDER

President MacKenzie called the meeting to order at 8:33 a.m.

2. ROLL CALL

Directors present: Miller, Vásquez, Dorey, Reznicek, and MacKenzie.

Directors absent: None.

Staff present: Roy Coox, General Manager; Lisa Soto, Secretary of the Board; Eldon Boone, Assistant General Manager; Don Smith, Director of Water Resources; Brian Smith, Director of Engineering; Brett Hodgkiss, Administrative Services Manager; Frank Wolinski, Operations and Field Services Manager; Marlene Kelleher, Finance Manager; and Marian Schmidt, Administrative Assistant. General Counsel Joel Kuperberg was also present.

Other attendees: VID Special Counsel John Carter joined the meeting at 10:07 a.m.

3. PLEDGE OF ALLEGIANCE

Director Miller led the pledge of allegiance.

4. APPROVAL OF AGENDA

15-11-110 Upon motion by Director Vásquez, seconded by Director Reznicek and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Reznicek, and MacKenzie), the Board of Directors approved the agenda as presented.

5. PUBLIC COMMENT TIME

Ms. Catherine Dickerson, a member of the public from Solana Beach, said that there are citizens who are seriously concerned about the Governor's refusal to allow the people of San Diego to use the water we have as a result of the water industry's efforts and the public's money. She asked that the District consider adding to its website information about additional sources of water that are either already online or coming soon such as the Carlsbad Desalination Plant. She said that people need to know that the Region actually has no shortage of water, despite the fact that we are in our fourth year of drought. The Board thanked Ms. Dickerson for her comments.

6. CONSENT CALENDAR

7. **DIVISION REPORTS**

See staff report attached hereto.

General Manager Roy Coox updated the Board about the relocation of a portion of the Vista flume through the proposed Shea Homes' (Shea) Hidden Valley Estates housing project in Escondido. He stated that General Counsel Joel Kuperberg drafted a cost sharing agreement which has been sent to Shea Homes for review. Director of Engineering Brian Smith said that the draft agreement is still being reviewed by Shea, and will be brought back to the Board before being finalized. Mr. Smith said that Shea is continuing to work on the design for the flume relocation, and staff expects to see the first draft of the design fairly soon.

Operations Manager Frank Wolinski clarified that the construction of an HN-31 regulator enclosure off of Fairview Drive is to replace one that burned in a brush fire. The new enclosure is non-flammable.

8. MATTERS PERTAINING TO THE ACTIVITIES OF THE SAN DIEGO COUNTY WATER AUTHORITY

See staff report attached hereto.

Director Miller reported on recent tours he attended of the Olivenhain Power Plant and of the San Vicente Dam Raise project. He reported that the power plant is now able to perform at about 97-98 percent of capacity, and the dam raise project including the marina is now complete. Director Miller commented on issues regarding storage at the San Vicente dam if there is a significant storm event such as an El Niño. Director Miller reported that the project on Knob Hill to reline a section of pipe is still ongoing and the project to construct a bypass pipeline around the San Vicente dam is about half complete. Director Miller updated the Board on the Pumped Storage project, stating that the Water Authority board approved moving forward with the next phase of the project, which will be to hire a design team.

9. REPORTS ON MEETINGS AND EVENTS ATTENDED BY DIRECTORS, AND AUTHORIZATION FOR DIRECTOR ATTENDANCE AT UPCOMING MEETINGS AND EVENTS

Director Dorey reported on his attendance at a meeting of the San Luis Rey Watershed Council where assignments were made to a couple of open seats on the board. Director Dorey said there were speakers at the meeting from Caltrans and San Diego County to talk about the roadwork on eastbound Highway 76 along the San Luis Rey River.

Director Dorey reported on his attendance at a meeting of the Southern California Water Committee where Felicia Marcus received an award and spoke. Director Dorey said the second speaker was Fritz Coleman who is a weathercaster for KNBC-TV in Los Angeles. Mr. Coleman spoke about past and future El Niño conditions.

President MacKenzie reported on her participation in a CSDA Membership Committee conference call. She reported that CSDA's membership is now at 1087 members and renewals are at 99.4 percent. Royalties from preferred providers were over \$102,000 with the majority coming from Cal Trust. President MacKenzie stated that free online ethics training is being offer by CSDA to members that pay their dues by January 1, 2016.

Directors Dorey and Vasquez requested to attend the Council of Water Utilities meeting on November 17. Directors Miller and Reznicek requested to attend the CSDA Quarterly meeting on November 19.

15-11-112 Upon motion by Director Dorey, seconded by Director Vásquez and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Reznicek, and MacKenzie), the Board of Directors authorized the following attendances: Directors Dorey and Vasquez to attend the Council of Water Utilities meeting on November 17; and Directors Miller and Reznicek to attend the CSDA Quarterly meeting on November 19.

10. ITEMS FOR FUTURE AGENDAS AND/OR PRESS RELEASES

11. COMMENTS BY DIRECTORS

Director Vásquez reported on an article he read about a perfect storm brewing in the Pacific and how it might affect California and the snow pack in the Sierras. Director Vásquez said he also read an article about Lake Henshaw and the fact that My Country Club is open for hunting. The Board noted a full page article which ran in the Union Tribune about the grand opening of the Warner Springs Ranch Resort.

President MacKenzie reported on an effort by the California State Association of Counties, the League of Cities, and CSDA to address issues related to Proposition 218 (Prop. 218). This coalition of local government organizations is exploring options to provide additional flexibility for local water agencies to finance stormwater capture and flood control infrastructure and pursue voluntary conservation based water rates and lifeline rates. President MacKenzie stated that the ACWA Board called for the creation of a Board-level advisory committee to monitor the matter. President MacKenzie said that ACWA will be hosting a special webinar briefing on November 10 regarding Prop. 218 and related issues and activities. She and Director Reznicek both requested to attend this webinar.

15-11-113 Upon motion by Director Vásquez, seconded by Director Dorey and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Reznicek, and MacKenzie), the Board of Directors authorized President MacKenzie and Director Reznicek to attend the November 10, 2016 special webinar briefing by ACWA about Proposition 218 issues.

12. COMMENTS BY GENERAL COUNSEL

Mr. Kuperberg commented on new and upcoming groundwater regulations. Mr. Kuperberg said that he will be making a presentation at the upcoming ACWA conference on Wednesday afternoon about the recent Prop. 218 case involving the City of San Juan Capistrano and court guidance which has followed regarding the propriety and risks (or lack thereof) of using tiered rates under Proposition 218. Mr. Kuperberg will address the consequences of having tiered rates that do not meet Prop. 218's requirements, how tiered rates might be validated and thus shielded from litigation, and alternatives to tiered rates that may avoid conflicts with Prop. 218.

Mr. Kuperberg said that Jeremy Jungreis has been asked to work with the Upper San Luis Rey Watershed Authority (USLRWA) to develop and analyze possible corporate or governmental structures that would accommodate the entity becoming a groundwater sustainability agency. Mr. Kuperberg said that this creates a technical legal issue called joint representation. Mr. Kuperberg said that while Rutan's primary responsibility and duty is to the District, and the District is a member of the USLRWA, the interests of the two entities could at some point differ. Mr. Kuperberg said that normally in this situation, the General Manager simply signs a document allowing the joint representation. Director Dorey provided some background as President of the USLRWA. The Board discussed this matter briefly. Mr. Kuperberg advised that the groundwater sustainability issue will be going to the ad hoc groundwater committee for fleshing out, and there will most likely be another Board workshop scheduled on the matter as well.

13. COMMENTS BY GENERAL MANAGER

Mr. Coox informed the Board that there was 0.42 inches of rain at Lake Henshaw, and the water level was currently at 2,800 acre feet. Mr. Coox said the Holiday Employee Appreciation Luncheon was scheduled for December 15 at the District headquarters. Mr. Coox said that Sexual Harassment Training was being scheduled with Gordon Graham onsite on January 26, from 9:00 a.m. to noon. Some of the Board members indicated scheduling conflicts with this date. Mr. Coox said that staff would try to reschedule to another day when all of the Board can be present.

Mr. Coox said that staff is preparing a draft calendar for the 2016 Board meeting dates. He said that staff tries to maintain the established first and third Wednesday schedule as much as possible while working around any known conflicts for major conferences or water industry meetings. He said that President MacKenzie has provided some known conflicts which staff is trying to accommodate on the draft calendar. He asked that the rest of the Board also let staff know of any conflicts they may have on the first or third Wednesdays of each month. Directors Miller and Reznicek indicated an anticipated conflict on July 6. President MacKenzie stated that July 6 may also be a conflict for her. Director Miller stated that September 7 might also be a conflict for him. Director Dorey indicated that as President of the USLRWA, he set the USLRWA meetings for the second Wednesday of each month in order to not conflict with VID Board meeting. Consequently, any VID Board meetings moved to the second Wednesday would be a conflict for him, and he would have to miss the VID Board meeting.

A brief break was taken from 9:52 a.m. to 10:07 a.m. Upon return from break, VID Special Counsel John Carter had joined the meeting. Mr. Carter and Director of Water Resources Don Smith were present in the audience for the remainder of the meeting.

14. CLOSED SESSION FOR CONFERENCE WITH LEGAL COUNSEL

President MacKenzie adjourned the meeting to closed session at 10:07 a.m. for a conference with legal counsel per Paragraph (1) of subdivision (d) of Government Code section 54956.9 to discuss the following pending litigation:

a. San Luis Rey Indian Water Rights Litigation (Settlement)

The meeting reconvened in open session at 10:29 a.m. President MacKenzie declared that no reportable action had been taken.

15. ADJOURNMENT

There being no further business to come before the Board, at 10:29 a.m. President MacKenzie adjourned the meeting to November 18, 2015 at 8:30 a.m.

SUBJECT: TREASURER'S REPORT AS OF SEPTEMBER 30, 2015

<u>**RECOMMENDATION:</u>** Informational report concerning the investments of the District.</u>

<u>SUMMARY</u>: Attached for review by the Board of Directors is the Treasurer's Report as of September 30, 2015. The report is formatted to provide information as required by the California Government Code and the Vista Irrigation District Investment Policy. The Treasurer's Report contains both an investment summary and a detailed security listing. Also attached is a five-year cash flow forecast, which indicates the District's investments are sufficiently liquid to meet anticipated cash flow needs.

<u>DETAILED REPORT</u>: Activity for the quarter included deposits and withdrawals from the District's cash and cash equivalent accounts: checking, California Asset Management Program (CAMP), and Local Agency Investment Fund (LAIF). During the quarter \$4.5 million of Treasury bills matured and \$4.5 million of new Treasury bills were purchased.

As of September 30, 2015, the net unrealized gain on the portfolio was as follows:





- Conducted flume shutdown to replace hatch covers on MD and Daley benches and installed an 18" butterfly valve at MD-takeoff. Additionally, leaks were repaired on Twin Oaks and MD benches.
- Started main line replacement of Nipponite pipe on Shale Rock Road 500' of 8" PVC and three services. At 50% completion.
- Continued main line replacement of steel pipe on Estrelita Drive 3,300' of 12" PVC, 35 services and 4 hydrants. At 85% completion.
- Completed testing of new hypochlorite feed system at Plant #3. Removed gaseous chlorination equipment and associated electrical and plumbing components from that site.
- SCADA replaced weathered enclosure at HP reservoir and updated back panel. Integrated Station # 11 into the Pechstein area local network.
- Replaced control wiring and terminal block in all motor control center panels at Station # 10.
- Analyzed 100 routine (reportable to SWRCB) bacteriological samples. All samples were negative for total coliforms (TC-). The average chlorine residual for October was 2.53 mg/L.
- WQ Calls/Incidents for October received two odor calls. One call was related to drain odor. The second call was transient with an indeterminate cause.
- Henshaw completed SCADA panel construction for Well 15A, 29A, 31A, 58A and 91. Completed Well 78A SCADA communication and interface screens.


