MINUTES OF THE ADJOURNED MEETING OF THE BOARD OF DIRECTORS OF VISTA IRRIGATION DISTRICT

June 20, 2018

An Adjourned Meeting of the Board of Directors of Vista Irrigation District was held on Wednesday, June 20, 2018, at the offices of the District, 1391 Engineer Street, Vista, California.

1. CALL TO ORDER

President Dorey called the meeting to order at 8:30 a.m.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Director Vásquez led the pledge of allegiance.

4. APPROVAL OF AGENDA

18-06-61 Upon motion by Director MacKenzie, seconded by Director Sanchez and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Sanchez, and MacKenzie), the Board of Directors approved the agenda as presented.

5. PUBLIC COMMENT TIME

No public comments were presented on items not appearing on the agenda.

6. CONSENT CALENDAR

18-06-62 Upon motion by Director MacKenzie, seconded by Director Miller and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Sanchez, and MacKenzie), the Board of Directors approved the Consent Calendar, including Resolution No. 18-18 approving disbursements.

7. HB RESERVOIR STRUCTURAL EVALUATION

See staff report attached hereto.

Assistant General Manager Brett Hodgkiss provided an overview of the HB Reservoir Structural Evaluation project. He stated that the evaluation and rehabilitation of the HB Reservoir became a priority based on the recent rehabilitation work that was completed on the HP Reservoir, which was prompted by corroded and failing steel cable wrapping at the base of the tank. Mr. Hodgkiss noted that the condition of the steel wire wrapping of the HB Reservoir is unknown, and the presence of corrosion needs to be determined. He noted that one goal of the rehabilitation will be to remove the hypalon liner and repair any leakage in conjunction with improvements necessary for the tank to meet current structural and seismic codes.

Director MacKenzie inquired as to the project's timeline. Director of Engineering Randy Whitmann stated that an inspection of the tank will be for scheduled for July; it will take approximately one month to prepare the report once the visual inspection and structural evaluation tasks have been completed.

18-06-63 Upon motion by Director Sanchez, seconded by Director Miller and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Sanchez, and MacKenzie), the Board of Directors authorized the General Manager to enter into an Agreement for Professional Services with Richard Brady & Associates for the HB Reservoir Structural Evaluation in an amount not to exceed \$78,500.

8. MATTERS PERTAINING TO THE ACTIVITIES OF THE SAN DIEGO COUNTY WATER AUTHORITY

See staff report attached hereto.

Director Miller stated that there has not been a meeting of the San Diego County Water Authority (Water Authority) Board of Directors since his last report and that the next meeting will be a special workshop on June 28. He noted that potential workshop topics include Colorado River and Bay-Delta issues, pending rate cases, and communication and education matters.

Mr. Hodgkiss reported that he attended the Member Agency Managers Only and General Managers' meetings where the June 28 special workshop was discussed at both meetings. In addition to the topics noted by Director Miller, Mr. Hodgkiss said that other possible workshop topics include infrastructure and system operations and local and regional supplies. He said that it is anticipated that a follow-up workshop will be held in the fall. Mr. Hodgkiss reported that the Water Authority Board moved its review of the Bay-Delta policy principles from the June 28 Board meeting to July 26 Board meeting.

Mr. Hodgkiss said Water Authority staff provided a summary of the new water use efficiency legislation provisions and an overview of the implementation timeline. He noted that all provisions of the new water use efficiency legislation had to be fully implemented by 2023.

9. MEETINGS AND EVENTS

Director MacKenzie reported on her participation in a conference call with California Association Local Agency Formation Commissions Legislative Committee where Assembly Bill 2258 (AB 2258) was discussed. She stated that AB 2258 will establish a local agency formation commissions grant program for the payment of costs, including studies, associated with initiating and completing the dissolution of special districts listed as inactive.

President Dorey and Director Vásquez reported on their attendance at the Council of Water Utilities (COWU) meeting where Jerry Meral, Director of the California Water Program, Natural Heritage Institute, spoke about the 2018 Water Bond, explaining how it benefits San Diego County. Additionally, Sommer Kehrli, Ph.D., from the Centre for Organization Effectiveness presented information on leveraging employee engagement to improve performance. Director Vásquez requested Board approval of his attendance.

President Dorey reported on his attendance at a meeting of the San Luis Rey Watershed Council Board of Directors where the Council's finances were discussed. He also reported on his attendance at a meeting of the San Diego Branch, Groundwater Resources Association of California where Kevin McGillicuddy, Chief Hydrogeologist for the Roscoe Moss Company, presented information on the critical components of the well construction process with emphasis on well screen design.

18-06-64 Upon motion by Director Miller, seconded by Director Sanchez and unanimously carried (5 ayes: Miller, Vásquez, Dorey, Sanchez, and MacKenzie), the Board of Directors authorized Director Vásquez's attendance at the Council of Water Utilities meeting in San Diego on June 19.

10. ITEMS FOR FUTURE AGENDAS AND/OR PRESS RELEASES

Mr. Hodgkiss stated that the California Special Districts Association board election for the Southern Network, Seat A will be on the July 5, 2018 agenda.

District's scholarship contest and the Water Awareness Poster Contest award recipients.

12. COMMENTS BY GENERAL MANAGER

Mr. Hodgkiss informed the Board that the headquarters courtyard project is moving forward; phase one will include removing the planter area and replacing it with concrete, and painting the interior building walls. Once the walls have been painted, staff will evaluate the need to stain the concrete. He also wished Director Vásquez a very happy birthday.

There being no further business to come before the Board, at 9:32 a.m., President Dorey adjourned the meeting.

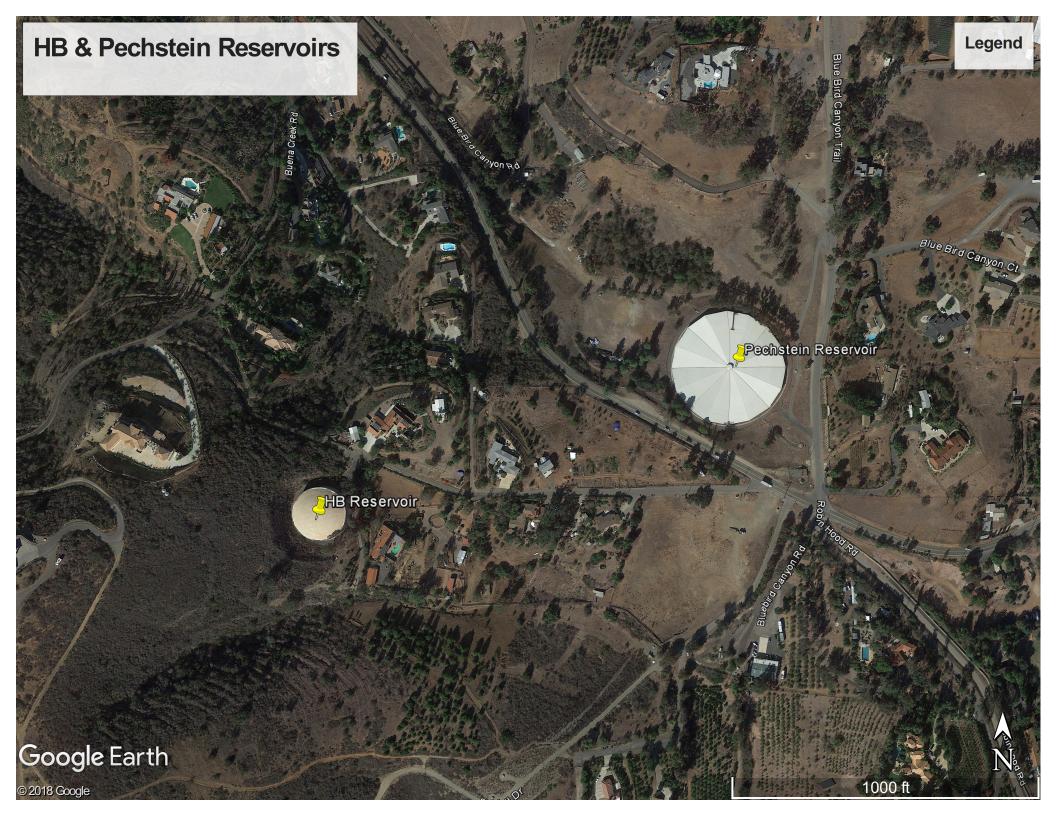
<u>SUMMARY</u>: The District's regional operation, emergency, and fire flow storage is primarily provided from three storage facilities: the 4.5 million gallon (mg) HB Reservoir, 20.0 mg Pechstein Reservoir, and 4.7 mg HP Reservoir. Both the HP and HB Reservoirs were constructed in the early 1960s and are nearly identical circumferential pre-stressed concrete tanks. Given the recent rehabilitation work that was completed on the HP Reservoir, which was prompted by corroded and failing steel cable wrapping at the base of the tank, the evaluation and rehabilitation of the HB Reservoir has become a priority.


<u>DETAILED REPORT</u>: HB Reservoir is located along Buena Creek Road, just west of Blue Bird Canyon Road and the Pechstein Reservoir. The condition of the steel wire wrapping is unknown, and the presence of corrosion needs to be determined. HB Reservoir also has a hypalon liner, which was installed in the late 1980s after a significant amount of leakage began to occur. A goal for rehabilitation will be to remove the liner and fix the leakage in conjunction with improvements that are necessary for the tank to meet current structural/seismic codes. Additionally, all appurtenances should be inspected for potential repair work and/or recommended upgrades.

The proposed contract is for the Phase 1 project evaluation and development. Key tasks include:

- 1. Perform visual inspection of the roof, walls and liner.
- 2. Expose and evaluate the condition of existing pre-stressing wire.
- 3. Perform a geotechnical investigation to obtain seismic and foundation design parameters.
- 4. Review existing design for compliance with current structural and seismic design codes. Check all structural components including floors, walls, columns, roofs, and the entire tank lid including all entry portals.
- 5. Explore repair options and provide project recommendations. Provide a cost, schedule, and service life estimate comparison between rehabilitating the existing reservoir and constructing a new reservoir.
